# are Options for You and Those You Love

Did you know that all Medicaid-eligible individuals with intellectual disabilities who qualify for an active treatment program are entitled to enjoy the advantages of GentleBrook's Intermediate Care Facilities? While the entitlement to receive care at an Intermediate Care Facility can be waived by individuals and their families, we think it should always be considered as a care option.

### What is an Intermediate Care Facility or ICF?

ICFs come in many sizes and settings to best serve the needs of individual clients. They can range in size from large buildings with many residents to smaller, home-like settings with just a few residents.

At GentleBrook, we offer six different ICF facilities at locations in Hartville and Coshocton, Ohio. Adult and adolescent residents living at our ICFs are entitled to these benefits:

- 24-hour supervision and on-site nursing care
- Active treatment including individualized work training supports and services
- Therapeutic services including physical, occupational & speech therapy, nutritional and social services
- · Life skills mentoring and support
- Social and recreational activities
- Transportation to and from work/activities
- Respite services



Individual facilities are licensed through Ohio's Developmental Disabilities Service System and we follow all Medicaid regulations that govern the staffing and administration of our facilities. In addition, all of our facilities are required to meet building code standards designed to protect the health and safety of our residents.

# What is Active Treatment and Why is it Helpful?

Active Treatment is a regimen of individualized habilitation and it's a key part of the ICF advantage. When clients are admitted to one of our ICFs, an interdisciplinary team of professionals is assigned to focus on their individual needs in the areas of health. nutrition, therapy, and behavioral and social development. We meet with parents or guardians to design an Individual Plan (IP) for the client with the goal of maximizing independence and







functional skills. The team is required to document the clients' progress toward meeting goals and collaborates with families to ensure our clients are given the best opportunity to succeed in their Individual Plan.

# What are the Financial Responsibilities for Residents of an ICF?

The ICF option is an entitlement under Ohio's Medicaid State Plan. The ICF entitlement covers the cost of room and board, personal care assistance, nursing and therapy services (if required), day habilitation services, and transportation services to work, therapy, appointments, shopping and recreation.



## How are Clients Admitted to a GentleBrook ICF?

Each case is unique, but admission to a GentleBrook ICF is attained through a process that includes evaluations and assessments of the individual applying for residency. We will help you in navigating the process and determining eligibility.
